#### **Educational Cooperation Agreement**

CONSIDERING the need to expand and increase exchanges, strengthening educational, material and human activities and actions in the socioeconomic and environmental spheres, aimed at implementing progressive policies in Latin America and expanding joint activities that contribute to the integrated and cooperative development of international relations in a globalized world;

CONSIDERING the constant questioning and deconstruction of democracy in Latin American countries and in the world, perpetrated by anti-democratic and reactionary groups;

CONSIDERING the urgency of developing and disseminating egalitarian public policies that promote the expansion of opportunities for all, whether at the national, regional, subcontinental or even international level;

CONSIDERING, on the one hand, the profusion of false news, of an exclusionary nature, especially through social networks and immaterial technological instruments, and, on the other hand, a notorious inability to produce answers that arrive quickly and are internalized by the population, including the distance and separation of progressive and democratic political institutions in Latin America and the world

The João Mangabeira Foundation, CNPJ 38.050.712/0001-98, address SHIS QI 05, Conjunto 02, Casa 02, Lago Sul, Brasília/DF (Brazil), CEP no. 71.615-02, entity established by the Brazilian Socialist Party (PSB), hereby represented by its vice-president, Alexandre Navarro Garcia, holder of CPF 385.346.061-53 and RG 962.490, SSP/DF and Associação Columbia Global Center/Brasil ("CGC-Rio", a non-profit association registered with CNPJ under number 15.730.628/0001-10 with its head office at Rua Candelária, 09 – 3rd floor – Downtown – Rio de Janeiro -RJ, hereby represented by its attorney-in-fact, Thomas JTrebat, economist, married, Director of CGC-Rio, propose to sign this Educational Cooperation and Exchange Agreement (Agreement), as defined in the following Articles:

#### **Article 1 - Object of the Agreement**

The main objective of this Political-Educational Cooperation and Exchange Agreement is to develop projects and activities that allow carrying out joint actions, aiming at:

- 1. The formation and better qualification of its members, sympathizers or people interested in proposing and defending causes oriented towards democracy and the validity of human and social rights, extended to all, without distinction;
- 2. The elaboration and discussion of joint local and international public policies, as well as their implementation, adapted to the norms and legislation of each country, as a way of offering room for the strengthening of democracy and social justice;
- 3. The dissemination of studies, public policies, political actions and publications by each Party, in order to increase synergy and expand the reach, profusion of ideas and practices defended by each institution, individually or collectively;

4. The support and funding of students linked to these institutions with the aim of training and creating opportunities for intellectual training and contribution to the end objectives of organizations.

## **Article 2 - Purpose of the Agreement**

In order to fulfill the objectives set forth in Article 1, the institutions agree to develop activities aimed at:

- 1. education and training, promoting the exchange of its courses on public and social policies;
- 2. the exchange of students selected by the institutions;
- 3. the production of knowledge in the form of articles, memos or other formats according to the interest of the parties.

### Article 3 – Legal and documentary exchange

- 1. Interchange your publications, newspapers, etc., reproducing these texts, documents, actions and public policies of each institution in your physical or technological means.
- 2. Exchange the legal terms and legislation that defines the functioning of Foundations and Organizations.

### **Article 4 - Execution of projects**

- 1. The directors of Fundação João Mangabeira and CGC-Rio may designate those responsible for each project, granting them powers to sign the project documents provided for in this Cooperation and Exchange Agreement.
- 2. For the fulfillment of its purposes, specific addendums will be signed for each project that is developed between the institutions, in which particular objectives and mode of operation will be established, as necessary.

### **Article 5 - Equivalence of functions**

1. The cooperation undertaken as a result of this Agreement will be established by the joint participation of the two institutions based on reciprocity and equivalence of actions, with the purpose of accelerating and establishing the qualified expansion of the activities of each institution.

### **Article 6 - Entry of new institutions**

1. The aforementioned clauses allow the participation of other institutions, whether political or not, from civil society, provided that they sign a Term in accordance with the objectives of this Agreement and are expressly approved by the two signatory institutions of this document.
